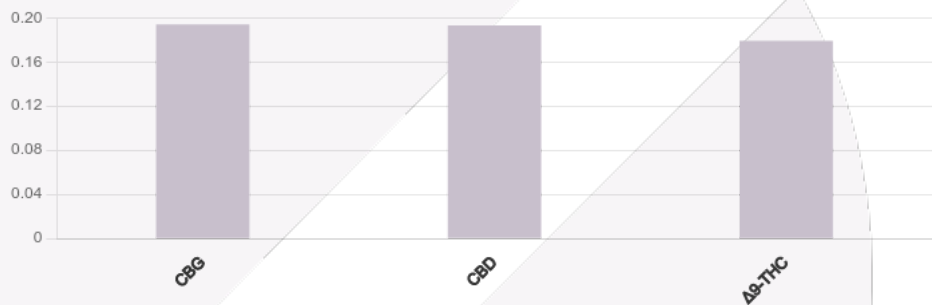
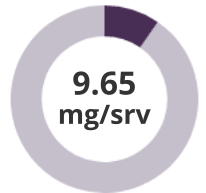
TOTAL CANNABINOIDS



TOTAL THC

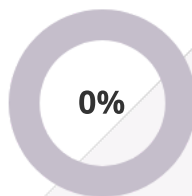
